

Terms and Conditions raffle “CMS 2025 – Personalized Logo Mats”

1. Organizer

The organizer of the sweepstakes is CWS Hygiene Deutschland GmbH & Co. KG, Dreieich Plaza 1a, 63303 Dreieich, info@cws.com.

2. Eligibility

Participation is open to all natural persons who are at least 18 years old and have their residence in Germany, Austria, or Switzerland. Employees of CWS and their relatives are excluded from participation.

3. Participation and Consent

Participation in the sweepstakes requires consent to the processing of personal data for advertising purposes. By submitting the sweepstakes form and ticking the corresponding box, participants agree that CWS Hygiene Deutschland GmbH & Co. KG may inform them about products, services, and events via email, telephone, or post.

Consent is given voluntarily under a “data in exchange for services” model. Participation in the sweepstakes is only possible with consent. 4. Data Protection

The personal data collected (e.g., name, email address, telephone number) will be used exclusively for the conduct of the sweepstakes and – if consent is given – for contacting participants. 5. How to Participate

Participation is possible by:

- Answering two mandatory questions,
- Optionally: answering a third question (voluntary, no effect on winning chances).

Each person may participate only once. Multiple entries or automated submissions will not be considered.

6. Prize

Among all valid entries, 5 CWS logo mats will be awarded. Cash payment, transfer, or exchange of the prize is excluded. The prize does not include any services in the full-service rental model and is limited to the one-time prize of a personalized logo mat.

7. Winner Selection & Notification

Winners will be selected randomly from all correct entries after the participation period ends.

Notification will be sent by email. If a winner does not respond within 14 days of notification, the claim to the prize expires, and a new winner will be drawn. The prize is non-transferable and cannot be paid out in cash. The organizer reserves the right to replace the prize with an equivalent item.
